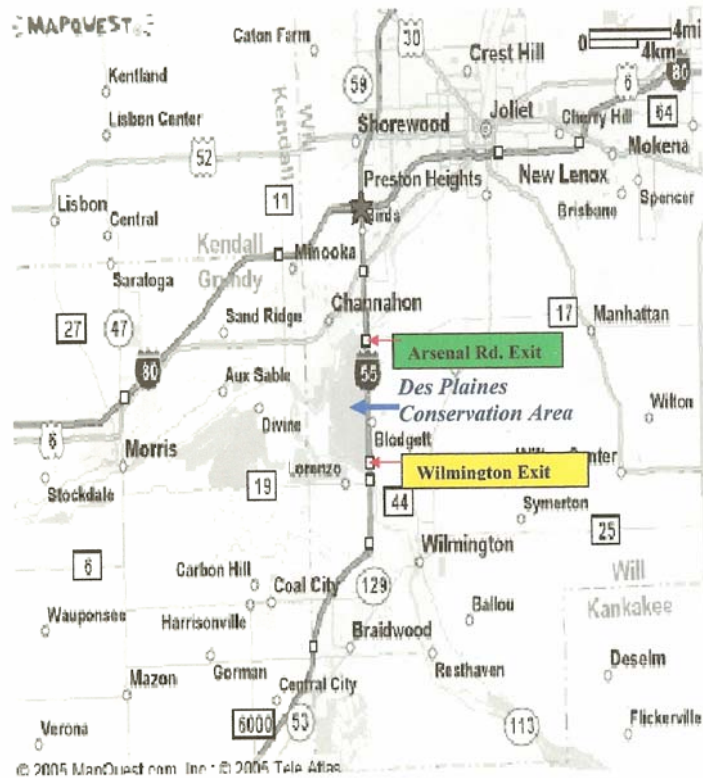

New Illinois State Laws Concerning AKC Licensed Hunting Tests and Field Trials

As of 2004, the state of Illinois requires that all participants in AKC Hunt Test and Field Trials must carry a valid hunting license and habitat stamp. This includes gunners, handlers, and scouts. This law does not apply to Illinois non-residents who wish to participate in any events. The sponsoring club will obtain a waiver of licenses for any non-resident participants.

Hunting licenses are available at Des Plaines on the west grounds through the concession in the building. They are also available through the IDNR web site at: www.link2gov.com/il/dnr/

Also persons born on, or after January 1st, 1980 must have taken a hunters education course to obtain a hunting license. To find a location nearest you, to attend these courses, visit: <http://dnr.state.il.us/lands/education/safety/hunt.htm>
