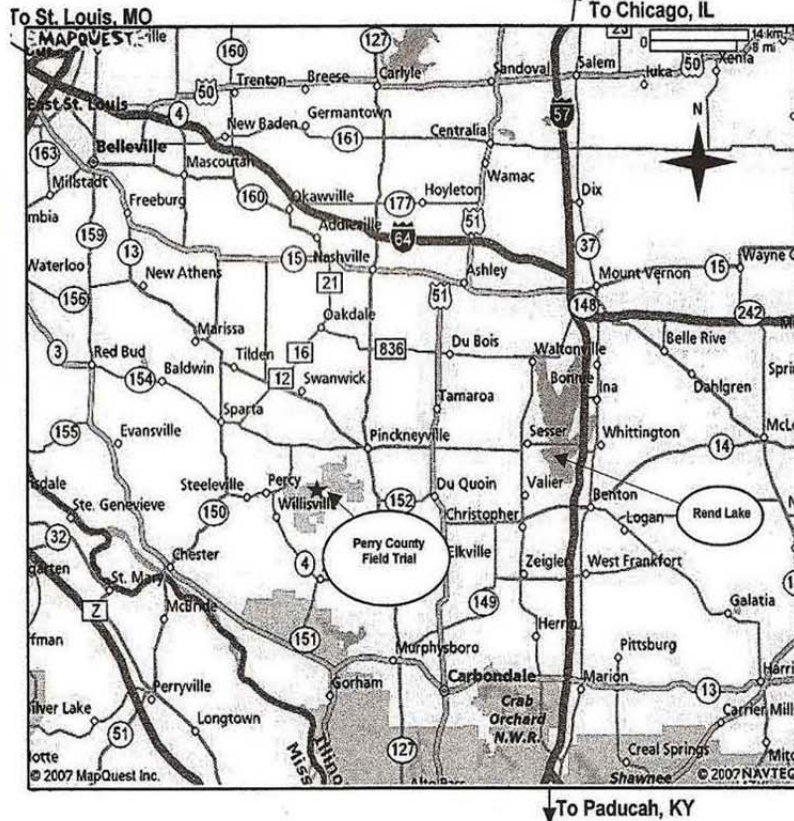

Alternate Route from Chicago, IL to Perry County Field Trial Grounds

- 1) I-57 South towards Sesser, IL
- 2) Exit 77, Route 154 West towards Sesser, IL (Rend Lake Field Trial Grounds)
- 3) Travel west on Route 154 to Pinckneyville, IL
- 4) Travel west on Route 154 towards Sparta, IL, turn left on Route 150
- 5) Travel to a 4-way stop next to railroad tracks. This is the intersection of County Line Rd, Rt 4, and Rt 150, just near the Hunt Club. Proceed straight on Rt 4 south towards Willisville, IL
- 6) Travel approximately 1 mile, past a camping ground and another set of railroad tracks. After the railroad tracks, turn left on the next blacktop road - Pyatt-Cutler Rd. (The Scuttle Inn is on the right)
- 7) Travel approximately 4.5 miles on Pyatt-Cutler Rd and turn left at the blacktop road entrance, just past the buildings/railroad cars where the fence ends. Follow the blacktop north to a few stop signs, jog to the left and continue north to the parking area at Captain Dove Field #1. (FYI - The Denmark Mine area is on the south side of Pyatt-Cutler Rd.

Route from Chicago, IL to Sparta, IL

- 1) I-55 south towards St. Louis, MO
- 2) Exit 33, Route 4 south towards Lebanon, IL
- 3) Continue Rt 4 south through Mascoutah, IL to Sparta

Route from St. Louis, MO to Sparta, IL

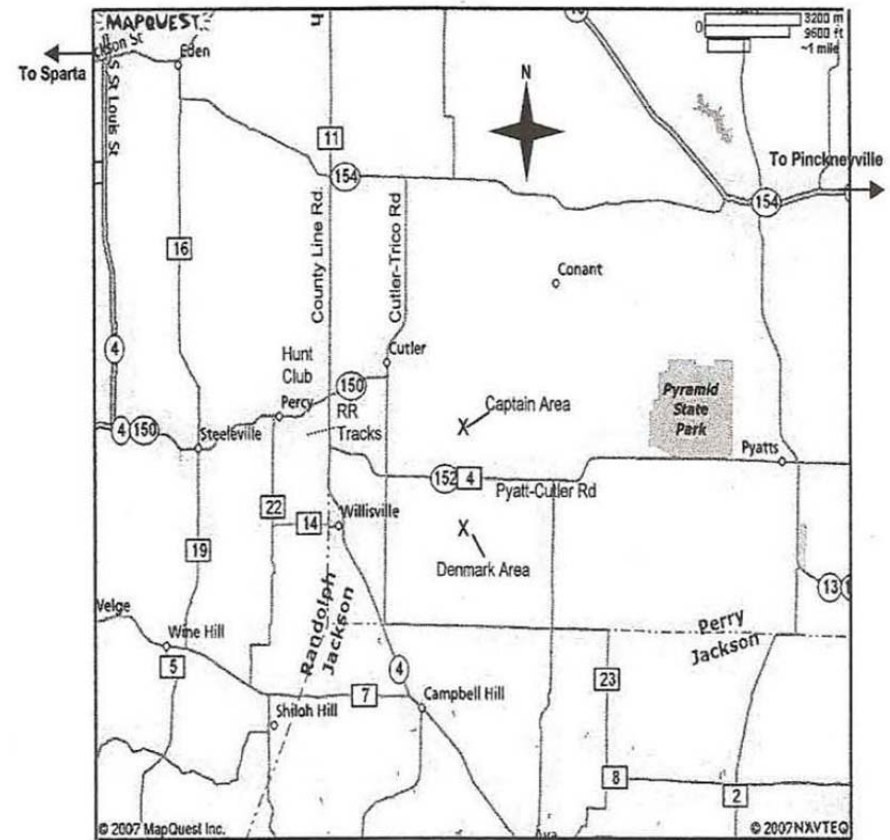
- 1) I-64 east into Illinois
- 2) Exit 23, Rt 4 south towards Mascoutah, IL
- 3) Follow Rt 4 south to Sparta, IL

Alternate Route from St. Louis, MO to Sparta, IL

- 1) I-270 south to I255 over the Jefferson Barracks Bridge into Illinois
- 2) Exit 6, Rt 3 south towards Columbia, IL
- 3) Follow Rt 3 south through Waterloo, IL to Red Bud, IL
- 4) At intersection of Rt 3 and Rt 154, go straight, going east on Rt 154
- 5) Follow Rt 154 east through Baldwin, IL to Sparta, IL

From Sparta, IL to Perry County Field Trial Grounds—Captain Mine

- 1) At the intersection of Rt 4 and Rt 154 in Sparta, IL, proceed east on Rt 154.
- 2) Travel approximately 7 miles on Rt 154 and turn right on County Line Rd.
- 3) Travel approximately 4.6 miles to a 4-way stop just past railroad tracks. This is the intersection of County Line Rd, Rt 4 and Rt 150, just near the Hunt Club. Proceed straight on Rt 4 south towards Willisville, IL.
- 4) Travel approximately 1 mile, past a camping ground and another set of railroad tracks. After the railroad tracks, turn left on the next blacktop road - Pyatt-Cutler Rd. (The Scuttle Inn is on the right.)
- 5) Travel approximately 4.5 miles on Pyatt-Cutler Rd and turn left at the blacktop road entrance, just past the buildings/railroad cars where the fence ends. Follow the blacktop north to a few stop signs, jog to the left and continue north to the parking area at Captain Dove Field #1. (FYI, the Denmark Mine area is on the south side of Pyatt-Cutler Rd.)

PLEASE NOTE: The directions above are to the Captain Unit. At direction point #5 you will travel about another half mile to the Denmark Unit entrance on the right.
