#### **ELIGIBILITY AND RISK**

Open to pointing breeds in good standing with the AKC. AKC-registered dogs must be 6 months of age or over on the event date. ILP dogs are eligible to participate. Bitches in season are not eligible and are not allowed on the grounds and entry fees will be refunded after providing a veterinary certification to the Hunt Test Secretary. Dogs are ineligible to enter a test if the test's Judge or Judge's family member has owned, sold, leased, boarded, trained or handled that dog within one year of the test date. Owners or handlers entering a test do so at their own risk and agree to assume responsibility for any damage caused by them, or by their dogs. They also agree to abide by the Rule of the AKC and the regulations for AKC Hunting Tests for Pointing Breeds.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

#### **ATTENTION**

Any one running, scouting, handling a dog or gunning MUST have a valid Illinois Hunting License with a habitat stamp if you are a resident of Illinois.
